# Holding Deposit

Applicants may be asked to pay a Holding deposit.

If your application is unsuccessful this deposit will be returned to you. If your application is successful this deposit will be transferred and form part of your security deposit or rent advance. Please note should you withdraw your application for any reason after processing has begun this deposit will not be refunded and will instead be paid to the landlord to compensate for lost time.

- Copy of TWO months most recent bank statements.
- Don't forget to sign the form with your Guarantor.
